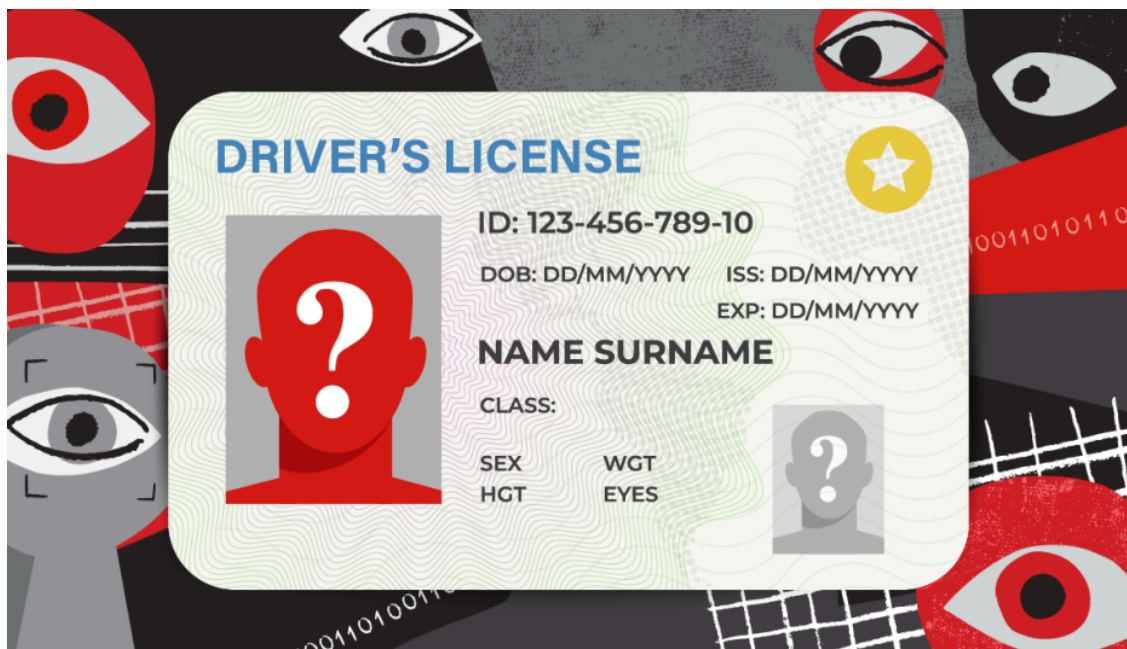
Guardianship for a Child: What Should You Know?

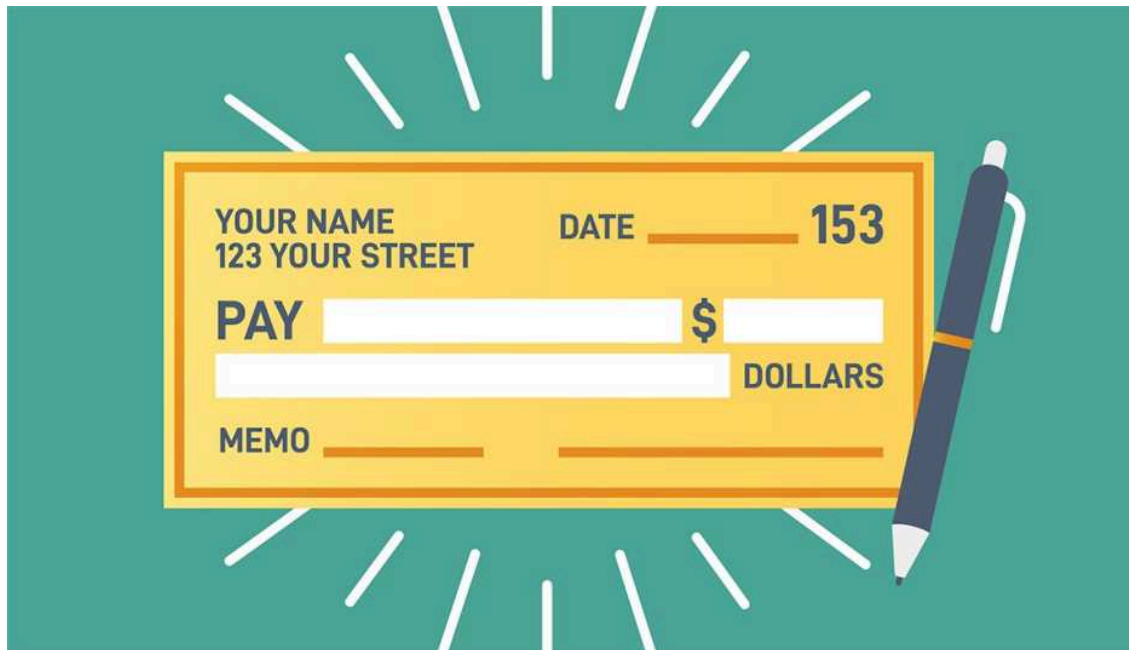
